REPORTS

CEO/ZEO: a) no response to the Stop Work order issued last month; b) has been out in the Town to view unsightly properties that I have received complaints about. Will follow up with owners.

<u>Insurance Committee:</u> it was decided that we would put out bids for insurance coverage every 2 to 3 years. We just did this last year so it will be another year or two.

H'way Supt: a) cleaning up snowplow turn-around areas; b) picking up roadside trash on Town and County Roads; c) passage of State budget allows for a 20% increase in CHIPS funding; d) the new loader is due to be delivered on 4/21/08; e) the sump pump at the Town Hall was replaced the last week of March **Town Clerk Report:** a) D&D Alarms here to test the entire alarm system, returned to install duress buttons in Courtroom; b) need to have more electrical outlets installed on the Courtroom bench due to increased electronics – will contact Mr. Ireland; c) after heavy snowfall in March, there was a leak into the Museum on the 3rd floor. We had a temporary fix done, but will need more; d) the zoning ordinance books will be sent to the printer soon; e) Mr. Hollwedel's class at the High School has been working on a project for a Town of Alexander Seal-he brought in the samples to share with the Board.

<u>Supervisor Financial:</u> The 2007 Annual Report has been completed and was shared with the Board members. This report includes the 2007 budget transfers.

<u>Tax Collector:</u> the tax roll has been turned in to the County, check book will be closed in approximately a week with payment of the penalty monies to the Supervisor.

Games of Chance: the 2007 financial report was completed and filed with the State.

<u>Building Committee:</u> Due to the water problem on the 3rd floor, we received an estimate to attach the copper flashing to the outside of the cupola roof which will take care of part of the problem. **Intercommunity Medical Center:** the Participation Agreement will be signed and forwarded.
