At that point we are on a limited time frame to approve our bonding resolution to be included in the Rural Development application (March 18<sup>th</sup>). Attorney DiMatteo and Supervisor Higley will be speaking with Dawn Kuras at the Rural Development office to clarify the timeframe. In the meantime, we need to address certain items that will also become part of the application.
