RESOLUTION NO. 77: TO DECLARE LEAD AGENCY. ISSUE A NEGATIVE DECLARATION AND ADOPT THE LOCAL LAW ENTITILED "TOWN OF ALEXANDER SOLAR LAW"

The Town Board of the Town of Alexander held a regular at the Town Hall located at 3350 Church Street, Alexander, New York on the 14^{th} day of August 2023, commencing at 6:00 p.m., and directly held a public hearing thereafter, and the following members were:

WHEREAS, all Board Members, having due notice of said meeting, and that pursuant to Article 7, §104 of the Public Officers Law, said meeting was open to the general public and due and proper notice of the time and place whereof was given as required by law; and

WHEREAS, the Town Board of the Town of Alexander is considering a proposed local law, entitled "Town of Alexander Solar Law", to regulate the placement of industrial solar energy facilities (SEFs) to protect the public health, safety and welfare of its citizens and visitors, and to minimize the adverse impacts on the Town of Alexander character and economy; and

WHEREAS, pursuant to §§239-I and 239-m of the General Municipal Law, said local law and all supporting documentation were submitted to the Genesee County Planning Board for review at their meeting on November 10, 2022, attached hereto as **Exhibit A** are the County comments; and

WHEREAS, the Town Board did hold a public hearing on the 14th day of August 2023 to consider the adoption of said local law; and

WHEREAS, the Town Board has sought Lead Agency status for the purposes of the State Environmental Quality Review Act (hereinafter "SEQRA") review of said project, by resolution dated July 10th, 2023; and

WHEREAS, the Town Board has received no objections to acting as Lead Agency and has established themselves as SEQRA Lead Agency; and

WHEREAS, the Town Board has reviewed the EAF, comments and input received from Genesee County Planning Board, the public, and the Town Attorney and shall complete parts 2 and 3 of the full EAF; and

WHEREAS, the Town Board, in accordance with SEQRA, has determined that the proposed local law will not adversely affect the natural resources of New York State and/or the health, safety and welfare of the public and is consistent with social and economic considerations and has determined that the proposed local law will result in no significant adverse environmental impacts.

NOW ON MOTION OF Councilperson Haller which has been duly seconded by Councilperson Schmieder, now therefore, be it

RESOLVED, that Town Board of the Town of Alexander hereby issues a Negative Declaration, and the Supervisor of the Town of Alexander is hereby authorized to sign Part 3 of the FEAF which will act as the SEQRA Negative Declaration; and be it further

RESOLVED, that the Town Board of the Town of Alexander hereby adopts the local law entitled "Town of Alexander Solar Law", to regulate the placement of industrial solar energy facilities (SEFs) in the Town of Alexander.
