## **Budget Discussion**

#2. The first item was salary changes. The Board went through the list of employees and made a few changes to salaries, mostly a 2% raise for the full-time personnel but leaving the Highway Superintendent's at the current rate. The janitor and transfer station attendant's hourly wages will be raised due to the minimum wage increase that takes place on 1/01/24. The Assessor's salary will increase due to the change in our contract with the Town of Batavia for her services.

The Fire Department tentatively will increase by 5%. We talked about the "Hydrant Rental" paid to the Village of Alexander. The Supervisor was asked to set up a meeting with the Village Board to discuss this topic.

We discussed the changes being made at the school as they have some Business Office people retiring and may not be able to continue doing our accounting and payroll. Several options were discussed going forward. Perhaps doing accounting in-house and having an outside company do the payroll. We will investigate options.

IT will have a separate line in the 2024 budget.

#3. There was a lengthy discussion of the job description that was presented. It centered around requiring the Highway Superintendent to attend Board meetings. In the end, it was decided to change "Other Duties performed once highway duties are satisfied, #2 Attends Board meetings and Budget meetings <u>and</u> submits a report of highway department activites."
